Marina Preko d.o.o. GENERAL TERMS

1. These General Terms shall apply to all berth holders during their stay in the area of Marina Preko.
2. Upon their arrival to Marina Preko for mooring, the crew is to report their arrival at the Reception, and submit ship's and identity papers.
3. Once the papers are delivered back to the vessel user, the vessel is considered to be taken over, and Marina Preko is free from any liability for the vessel.
4. Each taking in and out of the vessel equipment, listed in the Inventory List for the Annual berth Contractors, upon vessel's taking over, is necessary to be reported at the Reception.
5. No toilets can be used on the vessels while berthed in Marina Preko.
6. The collecting of waste, such as oil, diesel, detergents and other pollutants will be PERFORMED by the MARINA MARINEROS.
7. It is forbidden to light a fire or risk fire hazards in mooring and other areas of Marina Preko.
8. Every vessel must be equipped with fire-prevention equipment.
9. Use of speed boats, water-skiing, swimming, surfing or fishing during the stay in the marina is forbidden. Maximum speed limit should not exceed 2 nautical miles.
10. Piers and walkways must be free from any obstacles.
11. The power distribution cabinets can be used only for the purpose of supplying the proper electrical installations on board.
12. Vessel must be moored in a professional seamen-like manner, used in all ports for nautical tourism, and according to the instructions of Marina Preko staff. Mooring ropes must be of suitable length and quality to ensure proper berthing and to prevent any possible damage to other vessels.
13. All dogs and cats must be kept on a leash, and under control of their owners in mooring and other areas of Marina Preko at all times. We ask our animal friends for understanding. The owner or other person in charge or control of a pet shall expeditiously remove, clean or clear all feces deposited by the pet from the walkways and docks.
14. No laundering or drying of laundry is permitted at the piers or in other areas used by Marina Preko.

15. Upon leaving the vessel, for security reasons, it is necessary to unplug plumbing and electricity connections, or to dismount them.
16. It is necessary to have approval from the person in charge of mooring or from another Marina Preko authorised person in order to place warning signs or advertisements of vessel sale.
17. All persons shall reduce noise levels between the hours of 10:00 p.m. and 8:00 a.m, so as not to constitute a public nuisance.
18. Complaints can be submitted at the Reception.
19. Upon the arrival in mooring and other areas used by Marina Preko, provisions of the General Terms must be obeyed.
20. Should any of the provisions of the General Terms be violated, Marina Preko reserves the right to cancel the Contract on Berth Use.
21. In case of incurred damage, under any circumstances, Marina Preko is liable only to the amount specified in the liability insurance policy.

General Terms are drafted in the interest of our guests who decide to spend the most precious time of their holidays in our marina. Any suggestions which could contribute to a more enjoyable stay are most welcome. We wish you a pleasant stay in mooring and other areas of Marina Preko.
